

# GITI TIRE LIMITED TIRE WARRANTY



## ELIGIBILITY:

This Limited Tire Warranty applies to any new Giti tires produced by the manufacturer that bears the corresponding D.O.T. Tire Identification Number and sold by the authorized dealer.

The eligible tires are covered by this limited warranty against defects in materials and/or workmanship for **5 (five) years** counted from the date of manufacturing ("Warranty Period"). At that time, all warranties shall be deemed expired. The eligible tire shall be operated under a normal service and used on the same vehicle on which they were originally installed according to the vehicle manufacturer's recommendations ("Eligible Tires"). The warranty period for tube and flap is 2 (two) years counted from the date of manufacturing.

Any tires adjusted under this Limited Tire Warranty, will be replaced at no charge if the tire is reported during the first 1.6 mm of the original tread depth due to a substantiated defect in materials and/or workmanship. After the first 1.6 mm of the original usable tread and for the remainder of the Warranty Period, any warranty claim processed due to a substantiated defect in materials and/or workmanship will be adjusted on a prorated basis until the tread is worn down to 1.6 mm of tread depth remaining.

This Limited Tire Warranty does not apply to any tires which become unserviceable due to:

- Road hazard injury (e.g., a cut, snag, bruise, impact damage or puncture);
- Improper mounting and /or demounting operation on the tire;
- Bead failure due to excessive heat from brake system malfunction and/or aggressive use of brakes;
- Tires have been repaired or retreaded;
- Any other damages due to any non-conforming with manufacture's specification or instruction;
- Tire with premature or irregular wear due to misalignment , wheel imbalance and improper pressure, non-rotation of tire position, overloading, oil or chemical action, running flat and faulty shock absorber or brakes:
- Accident, fire, chemical corrosion, tire alteration or vandalism ;
- Flat spotting caused by an improper storage or brake lock;
- Weather Cracking or Ozone Cracking related to an improper storage condition;
- The addition of liquid, solid or gaseous materials other than air, nitrogen or carbon dioxide (for example, water based sealers or balancing substances) ;
- The tires serial number buffed or cut; damaged through use of any tube or flap.

## EXCLUSION:

All obligation or liabilities for loss of time, inconvenience, loss of use of a vehicle or any other consequential damages of all expenses are excluded. .

## CUSTOMER OBLIGATIONS:

The customer must present the claim tire to the authorized tire dealers;  
Applicable taxes, the cost of mounting, balancing and others service charges shall be paid by the customer.

## NOTE

In assessing the damage, the final judgment shall be made by our authorized representative staff or person.
